Whether or not the same individual is reelected to the Tribal Council, there shall be a new election of the position in question; and WHEREAS, TCR010919-01 of 03 appointed Merrill Reels as the Treasurer of the Mashantucket (Western) Pequot Tribal Council through 2019; and WHEREAS, TCR010920-04 of 06 re-appointed Merrill Reels as the Treasurer through 2022; and WHEREAS, Merrill Reels was re-elected to the Tribal Council at the November 6, 2022 Mashantucket (Western) Pequot Annual Meeting; and WHEREAS, the Tribal Council set November 18, 2022 as the deadline for submitting interest in serving as the Tribal Council Treasurer. At the time of the submission deadline Merrill Reels was the only one to express written interest in the position; and WHEREAS, the Tribal Council wishes for Merrill Reels to continue his performance in the Treasurer role for the span of his new term of office. WHEREAS, pursuant to TCR021218-05 of 06, for clarity of record, the Mashantucket Pequot Tribal Council hereby verifies that this 14-day advance submission requirement waiver was made at the time that this TCR was considered and voted upon. TCR011223-01 of 07-Amends the MPTN Entrepreneur Pilot Program, Directs Workforce Development to Assist Tribal Members with Developing a Successful Business Plan and Revises the Application Submittal to an Annual Basis (Amends TCR032521-01 of 03, TCR110421-01 of 04,

TCR052522-09 of 11). [Vote: 5 NUKS (YES) (Butler, Pearson, Reels, Whipple, Scott) 2 ABSENT (Cluff and Menihan)]. WHEREAS, economic independence and the well-being of Tribal Members is a strategic goal of the Mashantucket Pequot Tribal Nation (MPTN); and WHEREAS, TCR032521-01 of 03 approved the MPTN Entrepreneur Pilot Program; and WHEREAS, TCR110421-01 of 04 extended the MPTN Entrepreneur Pilot Program in hopes that at least one applicant would qualify and be approved for a loan at the conclusion of the second phase; and WHEREAS, TCR052522-09 of 11 directed Workforce Development to assist Tribal Members with producing a successful business plan and extended the Application Deadline to October 31, 2022; and WHEREAS, Unfortunately, no Tribal Members applicants have qualified thus far; and WHEREAS, the Treasurer, CFO and Director of Treasury ("Review Team") met with Workforce Development staff to determine the best course of

action to assist Tribal Members with obtaining a loan; and WHEREAS, the Review Team recommends that the Workforce Development assist Tribal Member applicants in creating a complete business plan; and WHEREAS, the Review Team also recommends that Tribal Member applicants meet with Workforce Development to have their business plan evaluated and approved prior to submitting a final application and Business Plan to the MPTN Entrepreneur Pilot Program Review Team; and WHEREAS, the Review Team further recommends that the application deadline for the MPTN Entrepreneur Pilot Program be changed to an annual basis on June 1st of each year with a target award date of July 15th; and WHEREAS, final approval for MPTN Entrepreneur Pilot Program applications will continue to be determined by the Review Team. THEREFORE, BE IT RESOLVED, the Tribal Council hereby directs Workforce Development to assist the Tribal Member applicants in creating a complete business plan. BE IT FURTHER RESOLVED, the Tribal Council hereby requires Tribal Member applicants to meet with the Workforce Development to have their business plan evaluated and approved prior to submitting their application and Business Plan to the MPTN Entrepreneur Pilot Program. BE IT FURTHER RESOLVED, the Tribal Council hereby establishes the application deadline for the MPTN Entrepreneur Pilot Program be changed to an annual basis on June 1st of each year with a target award date of July 15th. BE IT FINALLY RESOLVED, MPTN Entrepreneur Pilot Program shall continue on an annual basis until otherwise changed by Tribal Council to become a regular or dissolved program.

TCR011223-02 of 07-Reappoints Scott Reels to the Finance Committee As Member for a Term of Two (2) Years (Ratifies FC121622-01 of 02). Vote: 5 NUKS (YES) (Butler, Pearson, Reels, Whipple, Scott) 2 ABSENT (Cluff and Menihan)]. WHEREAS, the Mashantucket Pequot Tribal Finance Committee (FC) is a duly-authorized Standing Committee of the Mashantucket Pequot Tribal Nation Body; and WHEREAS, Tribal Member Scott Reels' term expired on October 8, 2022; and WHEREAS, on October 26, 2022, a Memorandum regarding vacancies on the MPTN Standing Committees was sent to Membership via U.S. Mail; and WHEREAS, the Finance Committee Chair did not receive any Tribal Member interest in serving on the Finance Committee; and WHEREAS, on November 27, 2022, a Memorandum regarding vacancies on MPTN Standing Committees was sent to Membership via U.S. Mail; and WHEREAS, on November 21, 2022, Tribal Member Scott Reels expressed interest via email to continue to serve on the Finance Committee; and WHEREAS, no other Tribal Members expressed interest to serve on the Finance Committee and it is the desire of the Chair of the Finance Committee to reappoint Scott Reels as member for a term of two (2) years; and WHEREAS, on December 16, 2022, the Finance Committee held a regular scheduled meeting and reappointed Scott Reels to serve as a member for a (2) two-year Term; and THEREFORE, BE IT RESOLVED, the Tribal Council hereby ratifies FC121622-01 of 02 (Exhibit A) and approves the appointment of Scott Reels to the FC for a (2) two-year Term, effective immediately.

TCR011223-03 of 07-Appoints Clifford Sebastian, IV to the Finance Committee As Alternate for a Term of Two (2) Years (Ratifies FC121622-02 of 02). Vote: 5 NUKS (YES) (Butler, Pearson, Reels, Whipple, Scott) 2 ABSENT (Cluff and Menihan)]. WHEREAS, the Mashantucket Pequot Tribal Finance Committee (the "Committee") is a dulyauthorized Standing Committee of the Mashantucket Pequot Tribal Nation Body; and WHEREAS, Tribal Member's Scott Reels, Kendra Perry-Young, and Kyle White's terms expired on October 8, 2022, creating a Member and two Alternate vacancies; and WHEREAS, on October 26, 2022, a Memorandum regarding vacancies on the MPTN Standing Committees was sent to Membership via U.S. Mail; and WHEREAS, the Finance Committee Chair did not receive any Tribal Member interest in serving on the Finance Committee; and WHEREAS, on November 27, 2022, a Memorandum regarding vacancies on MPTN Standing Committees was sent to Membership via U.S. Mail; and WHEREAS, on December 5, 2022, Tribal Member Clifford Sebastian, IV expressed interest via email to serve on the Finance Committee; and WHEREAS, Clifford Sebastian, IV, in the past has served honorably and respectfully on the Finance Committee; and WHEREAS, no other Tribal Members expressed interest to serve on the Finance Committee and it is the desire of the Finance Committee to appoint Clifford Sebastian, IV as alternate for a term of two (2) years; and WHEREAS, on December 16, 2022, the Finance Committee held a regular scheduled meeting and appointed Clifford Sebastian, IV to serve as alternate for a (2) two-year Term. THEREFORE, BE IT RESOLVED, the Tribal Council hereby ratifies FC121622-02 of 02 (Exhibit A) and approves the appointment of Clifford Sebastian, IV to the Finance Committee for a (2) two-year Term, effective immediately.

TCR011223-04 of 07-Revises the MPTN Inclement Weather Policy (Amends TCR112918-05 of 05 and TCR050822-02 of 02). Vote: 5 NUKS (YES) (Butler, Pearson, Reels, Whipple, Scott) 2 ABSENT (Cluff and Menihan)]. WHEREAS, the Mashantucket Pequot Administrative Support Committee (ASC) is a duly-authorized Standing Committee of the Tribe; and WHEREAS, the mission statement of the Committee, as approved by TCR081122-02 of 07, states that, "The Administrative Support Committee shall propose enhancement to existing MPTN administrative policy, procedures, processes, and standards to help meet the highest needs of the Tribal Community by improving MPTN administrative efficiency and

effectiveness"; and WHEREAS, at the February 4, 2022 Administrative Support Committee (ASC) regular meeting the Committee identified a priority list of existing policies they felt needed to be reviewed for possible efficiency and effectiveness improvements; and WHEREAS, TCR112918-05 of 15 changed the Mashantucket Pequot Tribal Nation (MPTN) Inclement Weather Policy to provide the Chief of Staff (COS) the ability to provide five (5) full day closures where team members would be compensated rather than the two (2) inclement weather days afforded to team members that they could independently choose to use at their discretion; and WHEREAS, TCR050522-02 of 02 approved a series of changes to MPTN and Mashantucket Pequot Gaming Enterprise (MPGE) Policies, with the intention of having stronger alignment in the policies of the entities. One such policy change was reverting the MPTN Inclement Weather Policy back to the two (2) inclement weather days for use at the discretion of the team members; and WHEREAS, the Committee reviewed the earlier policy as approved by TCR112918-05 of 15 and the current policy as approved by TCR050522-02 of 02 and compared the two (2). Ultimately, the Committee concluded that, while the Committee appreciates the effort to better align policies across organizations, the operational needs of MPTN are different than that of MPGE and in the case of the Inclement Weather Policy it is appropriate that they be different; and WHEREAS, the Committee reached this conclusion primarily due to the fact that unlike MPTN, MPGE is a 24/7 operation with the resources to provide accommodations during inclement weather for essential departments throughout the inclement weather period. Additionally MPGE is the primary focus of Public Works which, especially during times of staffing challenges, can take a significant period of time leading to government buildings not being cleared for team members to safely access on time to maintain normal operations; and WHEREAS, the Chief of Staff's Office also expressed a strong preference for the flexibility provided by the higher number of inclement weather days authorized at the discretion of the Chief of Staff following consultation with the Fire Department, Tribal Police, and Public Works; and WHEREAS, the Committee recommended via ASC121222-01 of 01 (Exhibit A) that the MPTN Inclement Weather Policy be modified to reflect the version from TCR112918-05 of 15 but maintain the Limited Emergencies section from TCR050522-02 of 02; and WHEREAS, during the Legislative Review and Analysis, the Office of Legal Counsel (OLC) suggested some minor language changes for clarity that did not detract from the Committee's intentions and the revised proposed policy (Exhibit B) is presented for Tribal Council consideration. THEREFORE, BE IT RESOLVED, the Tribal Council amends TCR112918-05 of 05 and TCR050822-02 of 02 in order to modify MPTN Policies Section V, Subsection 2 "Inclement Weather / Limited Emergency Policy" as demonstrated in Exhibit B.

TCR011223-05 of 07-Enactment of the Mashantucket Pequot Family and Medical Leave Law, 51 M.P.T.L. (Ratifies JC120222-01 of 02). Vote: 5 NUKS (YES) (Butler, Pearson, Reels, Whipple, Scott) 2 ABSENT (Cluff and Menihan)]. WHEREAS, the Council finds that promoting spirituality, strong family values, education, social stability, economic independence and the well-being of the community creates a strong cultural, social and economic foundation for the Tribe; and WHEREAS, the public policy of the Tribe is that all employees working within Tribal territory be treated fairly and consistent with the Tribe's cultural values; and WHEREAS, the Tribe, as an employer, provides employment to thousands of people in Mashantucket through its departments, divisions, entities and/or enterprises and has historically provided, through Tribal employment laws and policies, fair treatment to its employees, including comprehensive benefits and leave protections; and WHEREAS, the Council believes that codifying and strengthening the family and medical leave protections for employees of the Tribe will promote important cultural values and strengthen the community; and WHEREAS, the Council has considered and determined that it is important to require Tribal Employers to provide Tribal Employees with reasonable leave for medical reasons, for the birth, placement, and care of a child, for the care of a family member who has a serious health condition, and to support and care for seriously injured or ill military family members; and WHEREAS, the Mashantucket Pequot Judicial Committee (JC) is a duly-authorized Standing Committee of the Mashantucket Pequot Tribal Nation; and WHEREAS, TCR110394-04 of 04 approved the current mission statement for the Judicial Committee which states that, "The mission of the Judicial Committee is to assist the Mashantucket Pequot Tribal Council in the initial development of the Tribal Court and other such dispute resolution systems as are practical for the Mashantucket Pequot Tribal Nation. In performing its functions, the Judicial Committee shall not become involved in any individual case. The Judicial Committee shall for the consideration of the Tribal Council, develop ordinances which clearly define the jurisdiction of the Tribal Court and which describe other dispute resolution forums as make sense for the Tribe. The Committee shall also monitor the administration of Justice by the Tribal Court. This includes reviewing the overall quality and performance of the Tribal Court System, including but not limited to review of: 1) the equality of sentencing, 2) the fairness of the administration of the Pre-Trial Intervention Program. On an annual basis the Judicial Committee shall review and modify as necessary the Judicial Committee Mission Statement."; and WHEREAS, the Judicial Committee approved JCR120222-01 of 02 (Exhibit A) to recommend a new tribal law be enacted, the Mashantucket Pequot Family and Medical Leave Law (Exhibit B) to be enforced and administered by the Mashantucket Employment Rights Office (MERO) and the Tribal Court; and WHEREAS, the legislative process for a law proposed to be administered by the MERO provides for a public comment opportunity pursuant to 31 M.P.T.L., the Mashantucket Employment Rights Law, which public comment opportunity included sessions held via Zoom on September 21, 2022, September 24, 2022, September 27, 2022, September 29, 2022, October 1, 2022,

October 2, 2022, October 3, 2022, October 6, 2022, October 8, 2022 and October 12, 2022; and WHEREAS, all comments were advanced to the Judicial Committee who has reviewed those comments and made some revisions to the proposed law in response; and WHEREAS, the Council has reviewed the proposed law, the public comments, and the revised law, and supports the final version as submitted by the Committee. THEREFORE, BE IT RESOLVED, the Council hereby ratifies JCR120222-01 of 02 (Exhibit A) and approves of enactment of 51 M.P.T.L., the Mashantucket Pequot Family and Medical Leave Law (Exhibit B) to be enforced by the MERO. BE IT FURTHER RESOLVED, that the MERO is hereby directed to establish regulations consistent with this law to be published and in effect no later than 180 calendar days after enactment; and BE IT FINALLY RESOLVED, said law shall be effective upon passage and the MERO shall no later than sixty (60) days from enactment develop the necessary forms and materials necessary to administer the law.

TCR011223-06 of 07-Approves Revisions to the Judicial Committee Mission Statement (Ratifies

JC120222-02 of 02). Vote: 5 NUKS (YES) (Butler, Pearson, Reels, Whipple, Scott) 2 ABSENT (Cluff and Menihan)]. WHEREAS, the Mashantucket Pequot Judicial Committee (JC) is a duly-authorized Standing Committee of the Mashantucket Pequot Tribal Nation (MPTN); and WHEREAS, TCR110394-04 of 04 approved the current mission statement for the Judicial Committee which states that, "The mission of the Judicial Committee is to assist the Mashantucket Pequot Tribal Council in the initial development of the Tribal Court and other such dispute resolution systems as are practical for the Mashantucket Pequot Tribal Nation. In performing its functions, the Judicial Committee shall not become involved in any individual case. The Judicial Committee shall for the consideration of the Tribal Council, develop ordinances which clearly define the jurisdiction of the Tribal Court and which describe other dispute resolution forums as make sense for the Tribe. The Committee shall also monitor the administration of Justice by the Tribal Court. This includes reviewing the overall quality and performance of the Tribal Court System, including but not limited to review of: 1) the equality of sentencing, 2) the fairness of the administration of the Pre-Trial Intervention Program. On an annual basis the Judicial Committee shall review and modify as necessary the Judicial Committee Mission Statement."; and WHEREAS, periodically, the Standing Committees of the Tribe make recommendations to the Tribal Council to update their committee mission statements to reflect changes in direction, responsibilities, and overall purpose that have occurred over time; and WHEREAS, despite the current mission statement (Exhibit A) requiring the Committee to perform annual review and modifications to their mission statement it has not been modified by the Tribal Council in over 25 years and still references the "initial development" of the Tribal Court which just celebrated its 30th year of operation in April 2022; and WHEREAS, the Committee conducted an extensive review of their assigned responsibilities and held several meetings to discuss how to modify the mission statement to more accurately define their current functions; and WHEREAS, on December 2, 2022, the Committee finalized a revised version of their mission statement (Exhibit B) and formalized their request for Tribal Council to approve this new version via JCR120222-02 of 02 (Exhibit C). THEREFORE, BE IT RESOLVED, the Tribal Council hereby ratifies JCR120222-02 of 02 (Exhibit C) and approves of the revised Judicial Committee mission statement as presented in Exhibit В.

TCR011223-07 of 07-Approval of Additional Capital Funding for FY23 Requested for Critical

Projects for MPMRC and the MPTN Police Department. Vote: 5 NUKS (YES) (Butler, Pearson, Reels, Whipple, Scott) 2 ABSENT (Cluff and Menihan)]. Participation Forms on MPTN's Behalf. [Vote: 7 NUKS (YES) (Butler, Cluff, Pearson, Reels, Menihan, Whipple, Scott)]. WHEREAS, the Mission Statement of the Tribal Council, as amended pursuant to TCR011410-03 is to, "Preserve, protect and advance the Mission Statement of the Tribe for the benefit of the Mashantucket Pequot Tribal Nation"; and WHEREAS, the Native-American population has suffered some of the worst consequences of the opioid epidemic of any population in the United States. Tribal governments have had to spend considerable tribal funds to cover the costs of the opioid crisis, including increased costs for health care, social services, child welfare, law enforcement and other government services; and WHEREAS, over 400 federally-recognized tribes, including the Tribe, filed litigation against the opioid manufacturers, distributors, pharmacies, all of which the tribal plaintiffs maintain are responsible for the opioid crisis, which are part of the federal multi-district litigation In re: National Prescription Opiate Litigation, MDL. No. 2804, Case No. 17-md-02804 (the "Litigation"); and WHEREAS, the court-appointed Tribal Leadership Committee announced five (5) comprehensive settlements of opioid claims asserted in cases filed by the tribes against Teva, Allergan, Walmart, Walgreens and CVS (collectively, the "Defendants"); and WHEREAS, the Defendants have agreed to resolve the tribal claims for a total of \$603,000,000.00 of which Teva, an opioid manufacturer, will pay approximately \$119,000,000.00 over 13 years and Allergan, a related opioid manufacturer, will pay nearly \$71,000,000.00 over 6 years. For the pharmacies, Walmart will pay \$77,900,000.00 over one year; Walgreens will pay approximately \$148,000,000.00 over 15 years and CVS will pay approximately \$130,000,000.00 over 10 years; and WHEREAS, the Settlements only go into effect if certain tribal participation thresholds are reached; and WHEREAS, under the terms of the Settlements, each participating tribe has the right to determine which approved opioid abatement uses are best for the participating tribe and each participating tribe has the right to meaningfully participate in the final allocation process and a right to be heard prior to entry of the final allocation order; and WHEREAS, the Tribal Council is aware of and has reviewed the terms of the five settlements and elects to participate in the Settlements. THEREFORE, BE IT RESOLVED, the Tribal Council, in order to obtain and in consideration for the benefits provided to the Tribe pursuant to the Settlement Agreements, and acting through the authorized law firm, Skikos Crawford Skikos & Joseph, LLP ("Skikos"), hereby elects to participate in the five settlements and become a Participating Tribe as defined therein, and release all Released Claims against all Released Entities as defined therein.
