WHEREAS, pursuant to TCR020421-03 of 07, the Tribal Council previously approved the establishment of Command Holdings, A Pequot Company, a federally chartered corporation formed pursuant to 25 U.S.C. §5124 ("Command" or the "Corporation"); and WHEREAS, pursuant to Command Board Resolution 021022-01 of 06, a copy of which attached hereto as *Exhibit A*, the Command Board previously approved the By-Laws for the Corporation, a copy of which is attached hereto as *Exhibit B*, (the "By-Laws"); and WHEREAS, Article IX, Section 16 of Command's Charter provides that the Command Board may adopt By-Laws for the Corporation, "provided, however, that the Corporation's By-Laws and any amendments thereto shall be approved by the Tribal Council prior to being effective"; and WHEREAS, the Tribal Council now desires to ratify the Corporation's By-Laws consistent with Article IX, Section 16 of the Charter; and WHEREAS, pursuant to TCR021218-05 of 06, for clarity of record, the Mashantucket Pequot Tribal Council hereby verifies that this 14-day advance submission requirement waiver was made at the time that this TCR was considered and voted upon. **THEREFORE. (Vote: 6 YES (NUKS) (Butler, Cluff, Pearson, Reels, Whipple, Scott) 1 ABSENT (Menihan)]. WHEREAS, pursuant to TCR081017-02 of 07, the Tribal Council previously approved the formation of Copperhead Technologies, LLC ("Copperhead" or "Company") as a wholly-owned subsidiary of the Mashantucket Pequot Tribal Nation Business Development Company, LLC ("MPTN-BDC"); and WHEREAS, pursuant to TCR020421-03 of 07, the Tribal Council previously approved the formation of Command Holdings, A Pequot Company, a federally-chartered corporation formed pursuant to 25 U.S.C. §5124 (the "Section 17 Corporation"); and WHEREAS, on December 21, 2022, the MPTN-BDC assigned 100% of its ownership of Copperhead to the Section 17 Corporation; and WHEREAS, the Tribal Council now desires to approve certain amendments to Copperhead's Articles and Operating Agreement to facilitate such assignment; and WHEREAS, Article X of the Company's Articles of Organization provides that the Company's "Articles of Organization may be amended only by action of the Tribal Council of the Tribe at a meeting duly noticed"; and WHEREAS, Article 9 of the Company's Operating Agreement provides that "Operating Agreement may be altered, amended, repealed or new Operating Agreement adopted by the Tribal Council"; and WHEREAS, pursuant to TCR021218-05 of 06, for clarity of record, the Mashantucket Pequot Tribal Council hereby verifies that this 14-day advance submission requirement waiver was made at the time that this TCR was considered and voted upon. WHEREAS, pursuant to TCR092216-06 of 06, the Tribal Council previously approved the formation of the Mashantucket Pequot Tribal Nation Business Development Company, LLC ("BDC" or "Company") as a wholly-owned subsidiary of the Tribe; and WHEREAS, pursuant to TCR020421-03 of 07, the Tribal Council previously approved the formation of Command Holdings, A Pequot Company, a federally-chartered corporation formed pursuant to 25 U.S.C. §5124 (the "Section 17 Corporation"); and WHEREAS, the Tribal Council now desires to assign its ownership of the BDC to the newly formed Section 17 Corporation; and to further approve certain amendments to the BDC's Articles and Operating Agreement to facilitate such assignment; WHEREAS. Article X of the Company's Articles of Organization provides that the Company's "Articles of Organization may be amended only by action of the Tribal Council of the Tribe at a meeting duly noticed"; and WHEREAS, Article 9 of the Company's Operating Agreement provides that "Operating Agreement may be altered, amended, repealed or new Operating Agreement adopted by the Tribal Council"; and WHEREAS, pursuant to TCR021218-05 of 06, for clarity of record, the Mashantucket Pequot Tribal Council hereby verifies that this 14-day advance submission requirement waiver was made at the time that this TCR was considered and voted upon. THEREFORE, BE IT RESOLVED, pursuant to TCR021218-05 of 06, for clarity of record, the Mashantucket Pequot Tribal Council hereby verifies that this 14-day advance submission requirement waiver was made at the time that this TCR was considered and voted upon. ### TCR081023-04 of 11-Approves Amending 49 M.P.T.L. Re Cannabis (Revises TCR093021-01 of 13).

[Vote: 6 YES (NUKS) (Butler, Cluff, Pearson, Reels, Whipple, Scott) 1 ABSENT (Menihan)]. WHEREAS, the Natural Resources Protection Committee ("the Committee") is a duly-authorized standing committee of the Mashantucket Pequot Tribal Nation; and WHEREAS, there are currently 2 vacancies on the Natural Resources Protection Committee one being a long-standing vacancy due to the removal of Jodi-Ann Little Fawn and the other due to the removal of Nakia Northup due to the attendance rules outlined in the Standing Committee Protocol; and WHEREAS, pursuant to TCR012518-08 mailings have been conducted in search of new members but there had been a lack of interest by Tribal Members to serve on said committee; and WHEREAS, Tribal Members Matthew Byron and Jeremy Whipple have been the only individual to submit letters of interest to serve on the committee; and WHEREAS, the Tribal Council feels that both Tribal Members would serve diligently and would meet the ongoing needs of the committee.

TCR081023-07 of 11-Approves the September 19, 2023 Regular Meeting Agenda. [Vote: 6 YES (NUKS)] (Butler, Cluff, Pearson, Reels, Whipple, Scott) 1 ABSENT (Menihan)]. WHEREAS, TCR121522-05 of 07 approved the Tribal Council Meeting Agendas, including dates for the Regular Meetings with Membership, through December 31, 2023; and WHEREAS, there is a need for Tribal Council to further approve the discussion topics for the Regular Meeting Agenda, scheduled for Tuesday, September 19, 2023; and WHEREAS, on March 19, 2020, per TCR031920-01 of 01, the Tribal Council declared that a State of Emergency existed throughout the Mashantucket Pequot Tribal Nation due to the COVID-19 pandemic; and WHEREAS, given this State of Emergency, the Tribal Council approved TCR062520-04 of 10 to approve virtual meetings due to continued health concerns; and WHEREAS, on May 5, 2023, the World Health Organization (WHO) declared an end to the COVID-19 emergency; however, the State of Emergency in Mashantucket has yet to be ended; and WHEREAS, the low inperson attendance at both the March 21, 2023 and May 16, 2023 Regular Meetings with Membership has shown that the overwhelming majority of Tribal Members prefer to attend via Zoom; and WHEREAS, given the clear preference for attending via Zoom, the Tribal Council wishes to return to virtual attendance without an in-person option for the Regular Meetings with Membership through March 31, 2024. The Tribal Council will offer a poll regarding a return to hybrid options at the April 2024 Virtual Community Meeting to see if the position of the Membership has changed; and WHEREAS, TCR080620-01 of 01 confirmed that virtual attendance at a Membership Meeting will count towards qualifications for candidacy for the annual Tribal Council elections. THEREFORE, BE IT RESOLVED, the Tribal Council hereby approves September 19, 2023 Regular Meeting Agenda and discussion topics as follows:

WHEREAS, the Tribal Council desires to approve the Agenda for the Annual Meeting of the Mashantucket Pequot Tribal Nation (MPTN) to be held on the first Sunday of November each year (Sunday, November 5, 2023); and WHEREAS, per TCR082201-02, the Tribal Council Secretary prepares an Annual Meeting Information Packet (*Exhibit A*) for Tribal Members that includes:

- The date and Agenda for the Annual Meeting; The process and constitutionally-mandated qualifications for becoming a candidate for
  - Tribal Council and the process and date by which the Declaration of Candidacy must be filed;
- Additional miscellaneous information; and

WHEREAS, pursuant to TCR082201-02 of 03, the Annual Meeting Packet includes the agenda for the Regular Meeting immediately preceding the Annual Meeting (September 19, 2023 Regular Meeting Agenda approved by TCR081023-07 of 11); and WHEREAS, pursuant to TCR120122-06 of 07, the Tribal Council changed the Umbrella Leave Policy to require Tribal Members to sign-in with the Tribal Clerk's Office at the Annual Meeting in order to receive Paid Administrative Leave all day, all shifts the Monday following the Annual Meeting; and WHEREAS, on March 19, 2020, per TCR031920-01 of 01, the Tribal Council declared that a State of Emergency existed throughout the Mashantucket Pequot Tribal Nation due to the COVID-19 pandemic; and WHEREAS, given the continued State of Emergency, the Tribal Council approved TCR062520-04 of 10 to approve virtual meetings due to ongoing health concerns; and WHEREAS, on May 5, 2023, the World Health Organization (WHO) declared an end to the COVID-19 emergency; however, the State of Emergency in Mashantucket has yet to be ended; and WHEREAS, given the low in-person attendance at both the March 21, 2023 and May 16, 2023 Regular Meetings with Membership, the Tribal Council, pursuant to TCR060823-07 of 10, declared a return to the virtual meeting format (without an inperson option) for Regular Meetings with Membership through March 31, 2024; and WHEREAS, the Tribal Council desires to also maintain the virtual meeting format for the Annual Meeting; and WHEREAS, TCR080620-01 of 01 confirmed that virtual attendance at a Membership Meeting will count towards qualifications for candidacy for the annual Tribal Council elections. THEREFORE, BE IT RESOLVED, Tribal Council hereby approves of the Agenda and Information Packet Materials for the November 5, 2023 Annual Meeting of the Mashantucket Pequot Tribe (Exhibit A). BE IT FURTHER RESOLVED, the Tribal Council Secretary will mail the Annual Meeting Information Packet (Exhibit A) to every qualified Tribal Member for their review on or before Friday, August 25, 2023. E IT FINALLY RESOLVED, the Tribal Council Secretary will ensure proper communication to all Department Heads throughout the various Tribal Entities and Foxwoods Resort Casino that the Annual Meeting is approved under the Umbrella Policy for Tribal Members that attend to receive Administrative Leave with Pay all day, all shifts.

TCR081023-09 of 11-Authorizing the Filing of an Application with the United States Department of the Interior, Bureau of Indian Affairs, to Accept Title to 119 Indiantown Road, Ledyard, Connecticut in Trust for the Benefit of the Mashantucket Pequot Tribe. [Vote: 6 YES (NUKS) (Butler, Cluff, Pearson, Reels, Whipple, Scott) 1 ABSENT (Menihan)]. WHEREAS, the Tribe has consistently sought to reacquire traditional lands of the Tribe that have passed to non-Indian ownership and has pursued that objective prior to and after gaining federal recognition in 1983; and WHEREAS, the Tribe's Settlement Act provides authority for the Tribe to seek trust status for lands and establishes a federal reservation; and WHEREAS, as part of the Tribe's efforts to reacquire traditional lands in and around the Tribe's Reservation, in 2007, the Tribe acquired a parcel of land known as 119 Indiantown Road, Ledyard, Connecticut in a land swap with the Town of Ledyard by Warranty Deed (attached hereto as *Exhibit A*); and WHEREAS, in June of 2023, Boundaries, LLC, a state licensed surveying company with extensive experience in Southeastern Connecticut, completed a survey of 119 Indiantown Road, and based on that survey, prepared a metes and bounds description of the property which is attached hereto as *Exhibit B*; and WHEREAS, 119 Indiantown Road is comprised of approximately 76.74 acres in fee simple, which land is contiguous to the Tribe's Reservation and is also bounded on one side by Tribal fee property; and WHEREAS, the Tribal Council has determined that the future of the Tribe, its government and its citizens, as well as the economic development necessary to support selfgovernment is dependent upon a secure land base within the jurisdictional control of the Tribe; and WHEREAS, 119 Indiantown Road, Ledyard, Connecticut is presently forest lands used for hiking and ATV trails for Tribal Citizens, and the Tribal Council intends to leave this land in its present state for the enjoyment of the natural environment by the tribal community; and WHEREAS, the Tribe has performed initial archeological research and excavation on 119 Indiantown Road resulting in findings of a thin scatter of potentially significant materials and a recommendation to conduct additional research; and the Tribe is committed to preserving and maintaining sovereign authority and control over any such archeological sites; and WHEREAS, the

Tribe has prepared a comprehensive application addressing the statutory and regulatory requirements for acquisition by the United States of the property in trust for the benefit of the Tribe; and **WHEREAS**, the Secretary of the Interior is authorized to acquire land in trust on behalf of the Tribe pursuant to Section 5 of the Indian Reorganization Act, 25 U.S.C. § 5108 as confirmed and made applicable to the Tribe by the Mashantucket Pequot Settlement Act; and **WHEREAS**, pursuant to TCR021218-05 of 06, for clarity of record, the Mashantucket Pequot Tribal Council hereby verifies that this 14-day advance submission requirement waiver was made at the time that this TCR was considered and voted upon. **THEREFORE**, **BE IT RESOLVED**, pursuant to TCR021218-05 of 06, for clarity of record, the Mashantucket Pequot Tribal Council hereby verifies that this 14-day advance submission requirement waiver was made at the time that this TCR was considered and voted upon. **BE IT FURTHER RESOLVED**, that the Mashantucket Pequot Tribal Council does hereby authorize the filing of an application to and hereby requests that the Secretary of the Interior, or her designee, approve the Tribe's fee to trust application and acquire title to 119 Indiantown Road, Ledyard, Connecticut in trust for the benefit of the Mashantucket Pequot Tribal Council, or in their absence, the Vice Chair, is authorized, empowered and directed, on behalf of the Tribe, to execute and deliver such other certificates, documents, agreements and instruments, and to take such other actions, as in their sole discretion, are deemed necessary or appropriate to effectuate the terms of this resolution, and the acquisition of 119 Indiantown Road in trust for the benefit of the Tribe.

WHEREAS, the MPTN Director of Business Development and Executive Director of Public Works has requested from the Chair of the Economic Development \$30,000.00 from the ED Fund to be used for the future development of the 45 Frontage Road (Romanella Garage) property, including a wetlands study and Real Estate easement review (*Exhibit A*). [Vote: 6 YES (NUKS) (Butler, Cluff, Pearson, Reels, Whipple, Scott) 1 ABSENT (Menihan)]. WHEREAS, pursuant to Article X of the Constitution & By-Laws, the Tribal Council has the authority and responsibility to, "do any and all acts necessary or proper to the carrying on of Mashantucket (Western) Pequot Tribe and the management of its affairs" and generally has "the full management, control and disposal of the affairs and property and funds of the Tribe, to do all matters and things which the Tribe should do"; and WHEREAS, TCREX-062228-02 of 02 approved of a restructure of the Tribal Clerk's Office to create a Deputy Tribal Clerk and a Vital Statistics Specialist; and WHEREAS, these changes were part of ongoing Tribal Member focused succession planning efforts, such as outlined within TCR022323-02 of 05; and WHEREAS, part of the intention of TCREX-062228-02 of 02 was to require the hiring of a Tribal Member in the Vital Statistics Specialist position but, unfortunately, it was erroneously included in the requirement for the Deputy Tribal Clerk instead. It was also intended that the Deputy Tribal Clerk would have a higher level of signatory authority in the absence of the Tribal Clerk; and WHEREAS, the Tribal Council wishes to correct these errors immediately; and WHEREAS, a waiver of the 14-day advance submission requirement and the 30-day advance agenda approval mandate pursuant to TCR112101-02 of 03 is needed to address the issue on today's Tribal Council Agenda. THEREFORE, BE IT RESOLVED, the Mashantucket Pequot Tribal Council hereby waives the 14-day advance submission requirement and the 30-day advance agenda approval mandate approved in TCR112101-02 of 03 to allow this issue to be addressed in a timely manner.
